I. Meeting Participants

The meeting was convened by the planning process Co-Chairs:
Omar Benjamin, Executive Director, Port of Oakland
Jack Broadbent, Executive Officer, Bay Area Air Quality Management District
Margaret Gordon, West Oakland Environmental Indicators Project

Approximately 80 people attended the meeting, including West Oakland residents, public agency staff, environmental advocates, technical consulting firms, Port tenants and customers, public health advocates, community-based organizations, and staff of elected officials. Port Commissioners Anthony Batarse, Mark McClure, and David Kramer also attended portions of the meeting.

The facilitation team included Scott McCreary, Jon Mires, and Amy LeBlanc of CONCUR, Inc.

II. Key Points of Discussion and Presentation (in the order presented/discussed)

A. Port Maritime Focus: Parameters of the Planning Effort

The MAQIP will address emission sources within the Port's Maritime Operations Area and their effects on air quality in West Oakland (defined geographically for this process as the area bounded by the 880, 980, and 580 freeways). CONCUR's working definition of "stakeholder" for this process:

A stakeholder is any person that has an interest in the outcome of the Port of Oakland's planning process to develop a Port of Oakland Maritime Air Quality Improvement Plan.

E. Task Force Nomination Process

The Port of Oakland and the Co-Chairs launched a Task Force recruitment and nomination process. F. Planning Process: Key Topics of Discussion

Participants posed a series of questions and offered suggestions on several key areas of the proposed MAQIP process.

Process Details that Merit Refinement

- 1. Plan Adoption Process
 - a. What is the sequence of steps by which the Port Commission will be engaged in finalizing or adopting the Plan?
 - b. What process models can be incorporated to bring Task Force recommendations directly to the Port Commission? Might there be a scenario where the Task Force forwards recommendations to the Port Commission that are not supported by staff?
 - c. How will decisions be made as to what text will be included in the final Plan? Might multiple options on some issues be carried forward for Commission consideration?
 - d. Will the Plan be subject to CEQA Review?
- 2. What steps can be taken to make the West Oakland community broadly aware of the Task Force nomination opportunity?
- 3. What specific formats will be used to provide "substantive deliberation" opportunities for Task Force members and other stakeholders?
- 4. How can explicit terms of community interest such as "environmental justice" and "economic equity" be incorporated into the charge of the Task Force? How can these considerations be effectively incorporated in the planning process?

The CONCUR team noted that additional refinements to the process design will be layered in over the next month and discussed at the June 11 meeting of the Task Force.

With respect to the question on potential methods to determine which text should be carried forward into the Plan and then to the Port Commission, CONCUR described several available methods they have used in past collaborative planning processes:

- 1. Develop a menu of multiple options and use straw voting to clarify preferences;
- 2. Carry forward multiple options for Commission consideration;
- 3. Devise ranking or prioritization exercises.

Harold Jones, Deputy Director, External Affairs for the Port of Oakland, speaking on behalf of Co-Chair Omar Benjamin, stated that he envisions the Co-Chairs presenting regular progress updates on the planning process to the Port Maritime Committee. He also expressed support for forwarding the text of Task Force recommendations to the Port Commission.

Process Suggestions Offered by Participants

- 1. The Co-Chairs and Facilitation Team should strive to schedule public meetings at times and locations that are convenient for community members. Particular consideration should be given to meeting in West Oakland and to holding meetings in the evening.
- 2. The list of meeting attendees should be compiled and made available to those who attended.
- 3. Meeting documents prepared by CONCUR and the Planning team should be posted online for public access.

- 4. One method for the Port to demonstrate its commitment to the Task Force would be to charge the Task Force with setting the goals for the Plan and the criteria for choosing options.
- 5. At the introduction of Co-Chair Margaret Gordon, Swati Prakash of the Pacific Institute offered several process recommendations developed by the Pacific Institute and the West Oakland Environmental Indicators Project:
 - a. Formalize the Task Force role so there are clear linkages and between Task Force recommendations and elements of the final Plan.
 - b. Structure technical deliberations so that technical consultants and stakeholders work side-by-side.
 - c. Consider a broad range of criteria in evaluating potential Plan measures.
 - d. Prioritize community and public health considerations in considering strategies and Plan elements.

G. Overview of some Key Inputs to the Plan

Agency staff, Port staff, and Port technical consultants presented an overview of some key inputs to the planning process, including:

1. **Port of Oakland Emissions Inventory -** expected to be completed within the next month and will be publicly available on the Port of Oakland website.

West Oakland Human Health Risk Assessment (HRA) - draft report for public review is expected to be completed in early- to mid-Fall, 2007. The scope of the MAQIP is not intended to exactly mirror the scope of the HRA. The primary health outcome associated with diesel particulate matter is cancer, and this will be a main focus of the HRA, consistent with experience at the Ports of Los Angeles and Long Beach. The decision to structure the analysis using average emissions was based on the Air Resources Board's staff experience with the Ports of Los Angeles and Long Beach, and is linked to the issue focus on chronic cancer risk from diesel emissions.

2. Evolving Regulatory Programs

Jack Broadbent of the Bay Area Air Quality Management District (BAAQMD) described the BAAQMD's emerging regulatory program, the Green Ports Initiative, which is a regional regulatory program directed at the five ports in the Bay Area. Bill Sylte, consultant to the Port, provided an overview of the Air Resources Board Goods Movement Emission Reduction Plan, which appears on slides 15-18 of the Port's PowerPoint Presentation Slides, available at http://www.concurinc.com/portofoakland.

Matt Haber of the EPA also described 3 key developments at the federal and international levels that may inform or affect the MAQIP process, including proposed rules to regulate small marine vessels and locomotives and the MARPOL Convention's consideration of strict rules on fuel sulfur content in marine vessels.

3. Infrastructure Bond Funding
